A BY-LAW TO AMEND BY-LAW B-45, TOWN OF HARTLAND MUNICIPAL PLAN

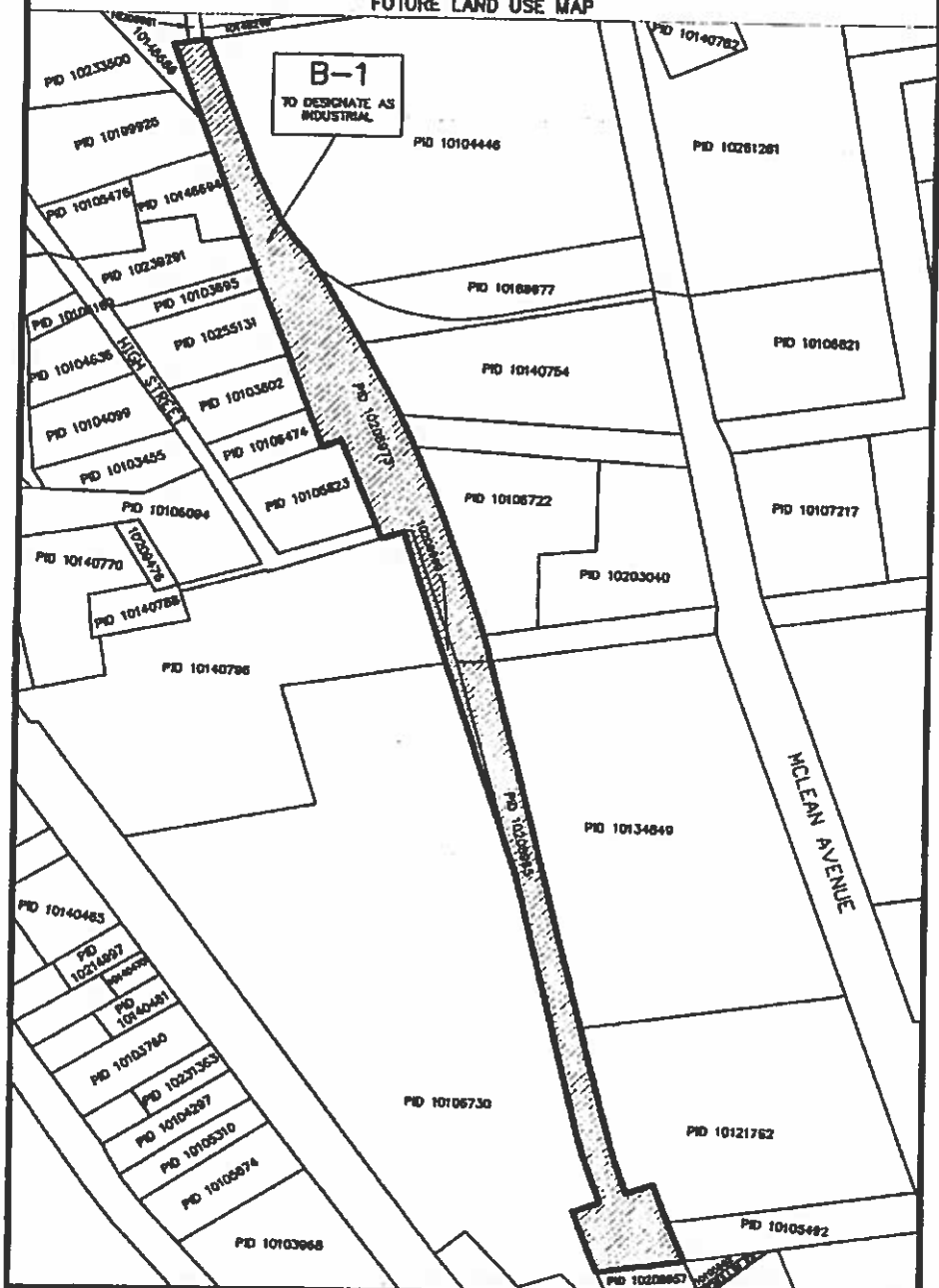
