BY-LAW NO. B-14 OF THE TOWN OF HARTLAND

BEING a By-Law respecting the maintenance and operation of the Solid Waste Disposal Site.

1. DEFINITIONS

(1.0) "Solid waste" means waste with insufficient liquid content to be free-flowing.

2. TOWN TO OPERATE

(2.0) The Town of Hartland shall cause to be maintained and operate a solid waste disposal site.

(2.1) The solid waste disposal site shall be located south of the Rockland Road so-called, as approximately outlined on the plan attached to this By-Law which plan forms part of this By-Law.

(2.2) The Town may cause to be erected such fences, barriers, entrances, gates and devices as is required to properly maintain and operate the solid waste disposal site; and to control entry and exit therefrom.

(2.3) The Town may from time to time hire, appoint or otherwise direct such employees or additional employees as may be reasonably required to supervise the use of the dump.

3. HOURS OF OPERATION

(3.0) The solid waste disposal site shall be used by the holders of valid permits issued by the Town during the days and at the hours (the "Hours of Operation") from time to time established.

(3.1) The Town may from time to time by resolution enacted on recommendation of the Public Works Committee revise or amend the Hours of Operation that the solid waste disposal site shall be open, and may in such resolution state the date on which the revised or amended Hours of Operation shall become effective.

(3.2) The Town shall cause any revision or alteration in the Hours of Operation of the solid waste disposal site to be published in two consecutive issues of any newspaper having general circulation in the area, specifying in full the Hours of Operation and the effective date.

(3.3) The Town shall cause the initial Hours of Operation to be published in any newspaper having general circulation in the area on one occasion.

4. PERMITS.

(4.0) The Town may issue the following classes of permits:

(a) Town resident's Domestic permit.

(b) Non-resident's Domestic permit.

(c) Commercial user's permit.

(d) Contractor's permit.

(4.1.1) The Town shall cause to be issued to each residential household in the Town a Town resident's domestic permit.

(4.1.2) No fee shall be charged for a Town resident's domestic permit.

(4.2.1) Any person not being resident of the Town of Hartland may

apply to the Town for a Non-resident's permit for purpose of disposing of solid waste at the solid waste disposal site.

(4.2.2) The Town may issue to any applicant referred to in paragraph 4.2.1 a Non-resident's domestic permit.

(4.2.3) The Town shall charge a fee of \$25.00 per year to issue a Non-resident's domestic permit.

(4.2.4) The non-resident's domestic permit shall be renewed annually upon payment of the annual fee herein provided.

(4.3.1) "Commercial User" shall mean and include any business whether located in or outside of the Town of Hartland which disposes of solid waste which is non-toxic and non-hazardous.

(4.3.2) A resident commercial user shall refer to any business located within the Town limits.

(4.3.3) A non-resident commercial user shall be any other commercial user.

(4.3.4) A commercial user may apply to the Town for a commercial user's permit for purposes of disposing of solid waste at the solid waste disposal site.

(4.3.5) The Town may issue to any applicant referred to in 4.3.4 a commercial user's permit.

(4.3.6) The Town shall charge a fee of \$100.00 per year to issue a non-resident commercial user's permit.

(4.3.7) The Town shall not charge any fee to issue a resident commercial user's permit.

(4.3.8) The commercial user's permit may be renewed annually upon payment of the annual fee herein provided.

(4.4.1) "Contractor" shall mean and include any person or persons or Corporation which carries on business, in whole or in part, of waste removal.

(4.4.2) A contractor may apply for a contractor's permit for purposes of disposing of solid waste of a non-toxic and non-hazardous nature at the solid waste disposal site.

(4.4.3) The Town may issue to any applicant referred to in 4.4.2 a contractor's permit.

(4.4.4) The Town shall charge a fee of \$500.00 per year to issue a contractor's permit.

(4.4.5) The contractor's permit may be renewed upon payment of the annual fee herein provided.

(4.5) The Town may upon notice to the holder of any permit suspend or cancel any permit herein issued for cause.

5. OFFENCES AND PENALTIES

(5.0) No person (other than the holder of a valid permit) shall be entitled to use the solid waste disposal site for purpose of disposing of waste, garbage or any other material.

(5.1) Any person who violates clause 5.0 commits an offence and is subject to a maximum fine of \$100.00.

(5.2) No person whether the holder of a valid permit or not shall use the solid waste disposal site except during the Hours of Operation.

(5.3) Any person who violates clause 5.2 commits an offence and is subject to a maximum fine of \$100.00.

(5.4) No person shall dispose of any toxic substance, hazardous material or non-solid waste at the solid waste disposal site.

(5.5) Any person who violates clause 5.4 commits an offence and is subject to a maximum fine of \$100.00 and any costs incurred by the Town or any provincial authority pursuant to the Clean Environment Act.

(5.6) No person shall dispose of bulk potatoes, dead animals or auto bodies at the solid waste disposal site.

(5.7) Any person who violates clause 5.6 commits an offence and is subject to a maximum fine of \$100.00.

(5.8) No person shall light or start a fire at the solid waste disposal site.

(5.9) Any person who violates clause 5.8 commits an offence and is subject to a minimum fine of \$100.00 and a maximum fine of \$500.00.
