TRANSIENT TRADERS, PEDDLERS AND LABOURERS

A By-Law to Regulate and License Transient Traders, Peddlers  
and Labourers

BE IT ENACTED: by the Town Council of the Town of Hartland as follows:

1. All licenses for carrying on any business, trade or occupation shall be applied for in writing and shall be authorized by the Council and issued by the Town Clerk under the seal of the Town, every license so issued shall expire on the date set out in such license.
2. No non-resident or person not a permanent resident of the Town shall peddle or hawk on the streets or from house to house, articles of jewellery, books, pictures, picture frames and other articles or shall sell or offer for sale any bankrupt or other stock, goods or merchandise brought into the Town for such purpose, without first having obtained the necessary license to do so.
3. No transient trader, person firm or corporation whose name has not been entered on the assessment list of the Town in respect to income or personal property for the then current year or who occupies premises within the Town for a temporary period only, shall offer goods or merchandise for sale by auction or private sale or otherwise carry on a trade or business or offer goods and merchandise for sale within the Town.
4. For vending or canvassing for the sale of any article of clothing, footwear, house furnishings, dry goods, groceries, meats, food stuffs, nursery stock, horticultural products works of art and design, hardware, tinware, woodware, glassware, marble and granite goods, electrical, rubber and leather goods, jewellers and optician supplies, mechanics, electricians and builders supplies and equipment, engineers and sculptors supplies and products; heating, lighting and ventilating apparatus and attachments; plumbers supplies and outfits, coal copying and enlarging photographs and pictures, rubber stamps and stamping outfits; bric-a-brac and haberdashery, Ten Dollars per day, Twenty Dollars per week, Fifty Dollars per month and Two Hundred Dollars per year, shall be the license fee.
5. For vending and canvassing for the sale of pianos, organs, phonographs and other musical instruments, radios, furniture cabinet makers works, bicycles, tricycles, velocipedes, automobiles, tractors, flying machines, carriages, wagons, buggies, sleighs, sewing machines, typewriters, adding machines, addressographs, agricultural implements, patent and proprietary

medicine and druggists sundries - \$15.00 per day, \$40.00 per week, \$60.00 per month and \$100.00 per year shall be the license fee.

6. For soliciting subscriptions for stationery books, magazines, periodicals, newspapers and other publications: \$2.00 per day, \$10.00 per week, \$20.00 per month and \$50.00 per year.
7. For vending or canvassing for the sale of any article or articles not herein enumerated or not directly within the scope or limitation of any of the foregoing classifications, such fees as may be fixed by the Council, from time to time.
8. No person, firm or corporation non-resident of the Town or the County of Carleton, whose name is not entered on any assessment book or list in the said Town or County for the then current year, in respect of income or personal property, shall carry on any trade, art, calling, mystery profession, occupation or employment within the Town without first having obtained the necessary license to do so, the fee for which shall be \$2.00 per day, \$10.00 per week, \$20.00 per month and \$50.00 per year.
9. No license fee shall be necessary for any person to vend or sell or canvas for the sale of any above enumerated articles or other articles, goods or merchandise on the streets or any open plot of ground or in a public hall, rink, or other building when such is conducted in conjunction with a musical gift or other show, concert, exhibition or entertainment.
10. This by-law shall not apply to:
  - (a) Any farmer, or other person selling or offering for sale - firewood, meat, butter, fruit, vegetables or other farm produce, the product of his own land and labor.
  - (b) Commercial travellers or other persons selling direct to dealers who are ratepayers or licensees in the Town, and doing business therein.
  - (c) Minors, whose parents are ratepayers or licensees
11. Any person, firm or corporation who shall violate any of the provisions of this By-Law shall be liable to a penalty of not less than \$2.00 and not more than \$40.00 for each violation with costs and in default of payment, to imprisonment in the County Gaol not exceeding ten days.
