By-Law A-190

REPEAL OF BY-LAWS

1. AUTHORITY. The Council of the Town of Hartland, under the authority vested in it by section 81 of the *Local Governance Act*, enacts this by-law to repeal prior By-Laws as follows.
 - A. REPEAL OF BY-LAW A-01. By-Law A-190 repeals By-Law A-01, "*Respecting the Consolidation, Interpretation and Repeal of By-Laws*," enacted in 1977. By-Law A-01 lists and defines categories of by-law that are no longer applicable.
 - B. REPEAL OF BY-LAW A-05. By-Law A-190 repeals By-Law A-05, "*To Establish a Planning Advisory Committee*," enacted in 1973, By-Law A-05 is based on the Community Planning Act and has been made obsolete by the formation of the Western Valley Regional Service Commission.
 - C. REPEAL OF BY-LAW A-08. By-Law A-190 repeals By-Law A-08, "*Respecting the Bonding of Officers and Employees*," enacted in 1982, By-Law A-08 requires the Town of Hartland to hold a bond under the "Surety Bonds Act" to protect the Town against fraud perpetrated by Town officers or employees.
 - D. REPEAL OF BY-LAW A-09. By-Law A-190 repeals By-Law A-09, "*Respecting the Establishing of Reserve Funds*," enacted in 1983, By-Law A-09 refers to the one-time establishment of a reserve fund for specific purposes at that time, including capital street construction and riverfront beautification. The fund no longer exists.
 - E. REPEAL OF BY-LAW A-10. By-Law A-190 repeals By-Law A-10, "*Respecting the Establishing of Reserve Funds*," enacted in 1990, By-Law A-10 refers to the one-time establishment of a reserve fund to purchase capital machinery and equipment. The fund no longer exists.
 - F. REPEAL OF BY-LAW A-12. By-Law A-190 repeals By-Law A-12, "*Respecting the Establishing of Reserve Funds*," enacted in 1995. By-Law A-12 refers to the one-time transfer of \$16,000 from the General Revenue Fund to the General Reserve Fund.

- G. REPEAL OF BY-LAW A-13. By-Law A-190 repeals By-Law A-13, "*Respecting the Establishing of Reserve Funds*," enacted in 1996. By-Law A-13 refers to the one-time transfer of \$22,000 from the General Revenue Fund to the General Reserve Fund.
- H. REPEAL OF BY-LAW A-14. By-Law A-190 repeals By-Law A-14, "*Respecting the Establishing of Reserve Funds*," enacted in 1996. By-Law A-14 refers to the one-time transfer of \$10,000 from the Utility Operating Fund to the Utility Reserve Fund.
- I. REPEAL OF BY-LAW A-15. By-Law A-190 repeals By-Law A-15, "*Respecting the Establishing of Reserve Funds*," enacted in 1997. By-Law A-15 refers to the one-time transfer of \$30,500 from the General Revenue Fund to the General Reserve Fund.
- J. REPEAL OF BY-LAW A-16. By-Law A-190 repeals By-Law A-16, "*Composition of Council*," enacted in 2009. By-Law A-16 specifies Council shall consist of a Mayor and four (4) Councilors.
- K. REPEAL OF BY-LAW E-05. By-Law A-190 repeals By-Law E-05, "*Closure of Maple Street*," enacted in 1992. By-Law E-05 says Maple Street shall be closed to through traffic from November 15 to March 31. It no longer applies.
