IMPOUNDING CATTLE

A By-Law Relating to the Impounding of Cattle.

BE IT ENACTED: by the Town Council of the Town of Hartland as follows:

- 1. No horse, cattle, swine, sheep, goats or domestic fowl shall be permitted to run at large or be herded, tethered or pastured on any street or public place. The penalty shall be One Dollar (\$1.00) for each animal and Twenty-Five Cents (\$.25) for each fowl to be paid by the owner or person having possession.
- 2. Peace Officers shall, and other persons may, lay information before the Magistrate against the owner or possessor of such animals or fowl so running at large, herded, tethered or pastured.
- 3. In it the duty of the Peace Officer and cattle drivers to, and any other persons may, impound any animal or fowl so running at large, herded, tethered or pastured, contrary to the provisions of this By-Law; and require the pound keeper to keep such until the driver's and pound-keepers fees are paid.
- 4. Should the owner or possessor claim such animal or fowl from the driver, before actually impounding, and pay or tender him his fees, the driver shall deliver it to the owner. Such release shall not relieve the owner or possessor from the penalities incurred hereunder.
- 5. Any person taking or attempting to take an animal or fowl from the person driving it to pound, or who releases it from the pound without permission of the keeper, is liable to a penalty of Five Dollars (\$5.00) per offence.
- 6. When an animal or fowl is impounded, the keeper shall notify the owner thereof. If such is not liberated within two (2) days or if the owner be unknown, he shall advertise it for sale by notices, posted in three (3) conspicuous places in each ward for a period of six (6) days. If not then liberated and all charges paid, he shall sell the same at the time and placed specified in the notice.
- 7. The driver to the pound shall be entitled to Fifty Cents (\$.50) for each animal and Twenty-Fit/e Cents (\$.25) for fowl.
- 8. The keeper's charges shall be: for each animal One Dollar (\$1.00) for each fowl Fifty Cents (\$.50), for feeding and caring for each animal while in pound, Fifty Cents (\$.50) per day, for each fowl Ten Cents (\$.10) per day.

- 9. When the proceeds from the sale of any animal impounded and sold shall exceed the expenses incurred, the balance shall be paid to the owner but if he be not known, such balance shall be paid to the Treasurer and disposed of as the Council may direct.
- 10. Any person violating the provisions of this By-Law shall be liable on conviction to a penalty not exceeding Forty Dollars (\$40.00), to be recovered with costs in any court of competent jurisdiction.
